5) ELECTION OF NEW EXECUTIVE COMMITTEE FOR 2024:-

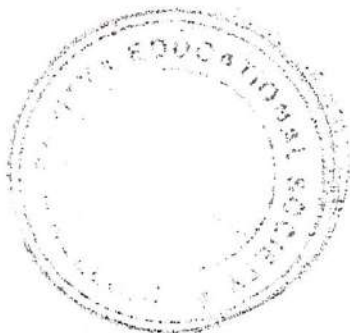
Resignation submitted by Sri Ch. Sireesh Babu for the post of E C member and for General body member was accepted Unanimously. Hence forth he is relieved.

Meeting was concluded by submission of vote of thanks by Smt. R. Premaja, Joint Secretary.



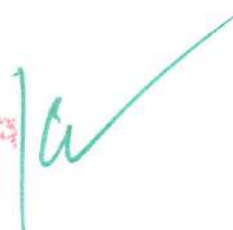
